Dogs cannot have competed in any SSA trial. Entrants are guaranteed 2 rounds with top ten going back to short go. You may enter, and/or handle, as many dogs as you want. Entry fee is \$300. A copy of registration papers MUST accompany entry form. Please add any information you would like to be printed in the program, such as, "for sale", ready for stud service, etc. Entry deadline is Sept. 30. (Starts @ 9:00 a.m. daily)
